Riders no longer need to be a member of BD in order to ride in BRC Dressage to Music qualifiers.

All music in CD format is to be handed in to the secretary at least 1 hour prior to the scheduled time of the test.

All entrants must submit a pre-entry to BRC (fees can be found in the current BRC Handbook) at least 21 days before the date of the qualifier. Pre-entries can be made via the pre-entry website <https://brc.bhs.org.uk/login?referral=%2Fselect> . Late pre-entries may be accepted at the discretion of the organiser with a late surcharge of £10 per individual and £20 per pair (payable to BRC HQ) if space permits. **Late entries cannot be guaranteed and so therefore must not be paid for until approval from the organiser has been gained.**

Once the pre-entry has been made, an area entry must be made via the details outlined on this schedule.

Withdrawals, Refunds and Cancellations:

BRC will credit note at their discretion, should the team manager need to withdraw any members from competition, it is up to the discretion of the organiser for refunds. If the event is cancelled and rescheduled within 21 days of the original event then all entries will remain and be carried over to the new date, with pre-entries for the qualifier NOT re-opening. If the new qualifier date is more than 21 days after the original date, then pre-entries will reopen and close again 21 days before the new qualifier date. Those unable to make the new date have 14 working days to claim a credit note from BRC. Eligibility will be taken from the close of the new entries date. For any qualifier that is cancelled and not rescheduled, clubs will have 14 working days from the date of cancellation to claim a credit note from BRC

Hats

All hats must have a visible current BRC/BE/PC PINK hat tag in place before they are worn on the showground, to show that they meet the current safety standards. Please note that the PINK Horse-Events Hat Tags will NOT be accepted. There will be a trained official available on the day to do this for you if your hat does not currently have one. For up-to-date hat rules please see the current BRC Handbook.

Flu Vaccinations

Your horse must have up to date influenza vaccinations in line with rule G7 in the current BRC Handbook. There is also a checking device on the BRC website. **please email clear photos with horse name in the task bar- a7passports@gmail.com . Before 26th January 2024**

Horses and ponies cannot be vaccinated within the 6 days before competition.

All Competing Horse's Passports to be emailed to a7passports@gmail.com for pre checking spot checks will be made on the day

RULES & CONDITION OF ENTRY WHILE AT KEYSOE INTERNATIONAL

- **All horses MUST have up to date flu and tetanus vaccinations and be prepared to show their passports upon request. The Operator runs on the 12-month vaccination rule.**
- **Horses must be properly secured when in their wagons or trailers. Ensuring the horses welfare is a priority.**
- **No horse is to be left unattended, or allowed to dig up the lorry park surface.**
- **No horses are to be tied to buildings, fencing or with hays nets outside of the trailer or horse box in the lorry parks.**
- **Horses must only move through areas shared with pedestrians at walk.**
- **Riding is only permitted in the arena/s. Horses can be mounted in the car park and walk mounted to the arena.**
- **Unless otherwise agreed by the Operator only food and drink purchased at KI may be consumed on site.**
- **Warming up is only permitted in the arena that has been hired. You must not warm up in any other area on the KI site.**
- **Lunging is not permitted in any of the arenas.**
Ensure that the gate into the arena is closed at all times and request entry or exit.
- **Pass left to left. Give way to riders in a faster pace.**
- **Arenas, lorry parks and walkways must be poo picked before you leave. CCTV is in operation and fines will be issued if these areas are not poo picked.**
- **No Hirer or their clients shall allow a stallion for which they are responsible as owner, lessee, authorised agent or rider to be on site without taking adequate precautions to ensure no one is put at risk of injury. Stallions must display a Stallion Disc and wear Stallion Ribbon in their tail.**
- **All Hirer's and their clients are deemed responsible and must ensure full compliance with**
- **relevant Health and Safety Policies. The Operator reserves the right to stop any activities which we**
- **consider to be contrary to our Health and Safety Policy or which we consider unsafe.**
- **Children aged under the age of 18 must be accompanied by a responsible adult (over 18). You are responsible for each child that you bring onto KI and shall ensure each child complies with these Conditions.**
- **purpose other than that for which it is supplied without express written authority.**
- **Mucking out of lorries into car and lorry parks is strictly prohibited.**
- **All litter must be disposed of in the bins provided or taken with you.**
- **Any accidents or incidents involving the rider, horse and/or spectator must be reported to the Operator at KI Reception immediately.**
- **Any damage or breakages must be reported to the Operator at KI Reception immediately.**
- **Smoking is not permitted anywhere on site. This also includes E-cigarettes and other forms of vapour emitting devices.**
- **Dogs are not permitted in any area except on the veranda, in the bar and the marquee unless required for disabled assistance (Assistant Dogs Only).**
- **Where dogs are permitted, they must well-behaved and kept on a short lead at all times.**
- **They must not be allowed to foul on the property. If this happens then any mess must be cleaned up immediately.**
- **You will be asked to remove your dog from the site if they are causing a disturbance.**
- **You may use mobile devices and point-and-shoot or compact cameras to capture images for your own private and domestic use (but you shall not use professional level photography or filming equipment).**
